4. Principal's

Report:

The Multicultural event was held on Thursday and was a great success. It was a lot of hard work by Shelley and Noor, and included participation from a lot of families. There were tables with cultural displays and activities, a fashion show, and a talent show. They are hopeful that next year there could be an evening component that includes a pot luck.

The grade 3 provincial assessments will be happening in May.

Teachers are planning field trips and report having trouble getting chaperones. We discussed again reminding teachers that the more notice that parents have, the more likely they are to volunteer, as it can take weeks to get clearances and book off work.

Today was the national Student Vote across the country. Ms Naylor's grade 4/5 class hosted the vote with the upper classes voting in a traditional voting set up.
